PLUMBING PERMIT APPLICATION PROCEDURE

All Plumbing Contractors <u>must</u> be licensed with the City of Robbinsdale. Property Owners who choose to do their own work *must* own *and* occupy the property and submit the Property Owner's Affidavit with the permit application.

CALCULATING THE PERMIT FEE:

Contract Value of Work up to \$10,000 multiplied by 2% with a Minimum Permit Fee of \$50 Contract Value of Work for more than \$10,000 is 2% of the first \$10,000 *plus* 1.5% of the remainder of the Contract Value

*The permit fee for the installation of an "appliance" only (water softener, range, dryer, or dishwasher, which does not involve the installation or replacement of gas piping), shall be \$15.00 plus the State Surcharge.

1) The cost of installations, alterations, additions, or repairs must include all labor and materials. It must include the cost of all materials supplied by the contractor, or by other sources. *The contract value of work by a homeowner shall be equal to the cost for labor and materials that would be charged by a Contractor*. All values shall be subject to approval of or, determined by, the Building Official.

2) REVISION OF ESTIMATED COST: The estimated cost shall be subject to review by the Building Official. Should the estimate not reflect the true cost it shall be revised and the applicant shall pay the fee based upon such revision. The Building Official may revoke any permit issued containing false information regarding the value of the work authorized by said permit pursuant to Section 89.150 of this Code. If the actual cost exceeds the estimated by five hundred dollars (\$500.00) or more, the applicant shall report within thirty (30) days after completion of this job, the actual cost to the Inspections Department and the fee shall be revised and the applicant shall pay a fee computed on the basis of the actual cost.

PLAN REVIEW FEES (if applicable):

When submittal documents are required by the code, a plan review fee may be required at the time of submitting the documents. Said plan review fee shall be 65 percent of the permit fee. The plan review fee specified in this subsection is in addition to the permit fee. When submittal documents are incomplete or changed, an additional plan review fee may apply.

CALCULATING THE STATE SURCHARGE:

Contract Value of Work x .0005 = the State Surcharge (Minimum State Surcharge = \$.50)
