**(a) AUDITOR'S SUBDIVISION NO. 180:**

- (1) Lots 8, 9, 10, 11, 12, 13, 14, except that part lying Southwesterly of the center line of U.S. Highway No. 52 and 218, and lying Northeasterly of the following described line: Beginning at a point in the Northwesterly line of said Lot 14, distant 127.00 feet Northeasterly of the Northwesterly corner of said Lot 14; thence running Southeasterly along a line parallel with and distant 127.00 feet Northeasterly of the Southwesterly line of said Lot 14 as measured along the Northwesterly and Southeasterly lines thereof, a distance of 218.08 feet; thence running Southeasterly 36.14 feet, more or less, to a point in the Southeasterly line of said Lot 14, said point being distant 146.12 feet Northeasterly of the Southwesterly corner of said Lot 14 and there terminating, and Lots 17, 18, 34, 35, and the southeasterly 40 feet of Lot 7 lying southwesterly of State Highway 52-218; *(3800-88 W Broadway Ave except 3839 Lakeland Ave N; 3700-10 W Broadway Ave; 3735-43 Lakeland Ave N; 3930 & 3934 W Broadway Ave)*
